The goal of the mentor relationship is to model good character, be a consistent and reliable presence in the life of the child, speak into their lives when appropriate and to cast vision for future development and growth.

Conducted basketball and soccer sports programs. The Common Good sports program brought organized sports to our target neighborhood for children in 2nd through 5th grades. Over 100 kids participated in soccer and basketball teams in the spring and fall of 2018.

The Common Good has been involved in advocating for the citizens of Northwest Tulsa.
